## BREEDING AGREEMENT

Hereinafter referred to as the **Mare Owner**, and Euro Horse Imports of 14 Voyageur Drive, Kemptville, Ontario, K0G 1J0, Canada, hereinafter referred to as the **Stallion Owner**, on this day of \_\_\_\_\_, respecting the breeding of **Creme De La Creme**, hereinafter referred to as the **Stallion**, and \_\_\_\_\_, hereinafter referred to as the **Mare**, subject to the following Terms & Conditions:

### TERMS AND CONDITIONS:

- Breeding Fee:** The promotional Breeding Fee as stated, to be paid by the **Mare Owner** to the **Stallion Owner** is **\$2,250.00** in CAD funds *or* **\$1,695.00** in US funds<sup>(1)</sup>.
- Booking Fee:** A booking fee of \$650.00 in CAD funds *or* approximately **\$475.00** in US funds<sup>(1)</sup> **is included** within the **Breeding Fee**.
- Fresh Cooled Collection Fee:** A collection fee of \$250.00 in CAD funds *or* **approximately \$180.00** in US funds<sup>(1)</sup> **is included** in the **Breeding Fee** and applies to the first **fresh cooled** collection **exclusively**. Subsequent shipments will be subject to the **Collection Fee**, and all collections are subject to shipping fees.
- Frozen Collection Fee:** A collection fee of \$160.00 in CAD funds *or* **\$125.00** in US funds<sup>(1)</sup> **is included** in the **Breeding Fee** and applies to the first frozen dose<sup>(7)</sup> **exclusively**. Subsequent shipments will be subject to the **Collection Fee**, and all collections are subject to shipping fees.
- Credit Card Authorization:** We require credit card authorization as part of this contract, and *will be used exclusively for shipping fees and any subsequent collection fees*<sup>(2)</sup>.
- The **Breeding Fee** is due upon the signing of this agreement. *Any promotional discounts will be noted in a separate document*<sup>(3)</sup>.

## **BREEDING AGREEMENT**

7. **Tax:** 13% HST applies to all **Canadian Purchasers**.
8. **Semen Collection Requests:** Written requests for fresh cooled or frozen semen must be received by 8:30am EST the day prior to collection, without exception, and must be filled out online via the *Semen Request Form*<sup>(4)</sup>, which is available on our website. Collection days will be Monday through Friday, and delivery from Monday through Saturday, depending on delivery location.
9. The **Mare Owner** agrees to breed **exclusively** to the **Mare**, as stated within this agreement.
10. **Live Foal Guarantee:** Should the **Mare** fail to conceive, abort, die, or not produce a *live foal*<sup>(5)</sup> then the **Stallion Owner** guarantees the **Mare Owner** shall have the right to re-breed or substitute a mare, upon discretion of the **Stallion Owner**, within the current **or** the following *breeding season*<sup>(6)</sup> exclusively. The **Collection Fee** and any related shipping fees are applicable to any subsequent collections.
11. Embryo Transfer: For embryo transfer breeding, we will honour the **Live Foal Guarantee** on one foal. For subsequent pregnancies, there will be an additional fee of \$1,050.00 in CAD funds *or approximately \$750.00 in US funds*<sup>(6)</sup>. Subsequent pregnancies will not be subject to the **Live Foal Guarantee**.
12. Creme De La Creme is **negative** for **EVA** and **WFFS**.
13. This agreement **must** be used within the next two *breeding seasons*<sup>(6)</sup>.
14. Should Creme de la Creme be unable to fulfill his breeding obligation via fresh semen due to health reasons, frozen semen will be available OR a refund will be given by the **Stallion owner** to the **Mare owner**.
15. The **Mare Owner** and the **Stallion Owner** agree that the terms and conditions stated herein are set for the entire duration of the **Breeding Agreement**.
16. The **Breeding Agreement** shall be interpreted in accordance with the laws of the Province of Ontario, and its validity and administration shall be governed by said laws.
17. The termination of this contract, if terminated by **Mare Owner**, is non-refundable in its entirety, **no exceptions**.
18. **All sales are final.**
